IMPOSING A MORATORIUM ON THE ISSUANCE OF PERMITS, LICENSES OR APPROVALS FOR

WIND ENERGY CONVERSION SYSTEMSAt a regular meeting of the Board of Commissioners of Shiawassee County, Michigan held at the County offices located at 201 N. Shiawassee St., Corunna, Michigan 48817 on the 9th day of November, 2017, at 5:00 p.m.

The following Resolution was offered by Commissioner _____ and seconded by Commissioner _____.

WHEREAS, MCL 46.11(j) authorizes the Shiawassee County Board of Commissioners (“Board”) to adopt and amend ordinances that relate to county affairs; and

WHEREAS, on December 14, 2016, the County Planning Commission recommended that the Board adopt a moratorium on approvals of Wind Energy Conversion Systems, on a limited temporary basis, so that the Planning Commission may review certain requirements of Sec. 4.3.76 of the Shiawassee County Zoning Ordinance, particularly those provisions regulating height, setbacks, shadow flicker, noise impacts, and decommissioning costs of Wind Energy Conversion Systems, and recommend any revisions necessary for the protection of the public health, safety and welfare; and

WHEREAS, the Board has determined that it is in the best interest of the public health, safety and general welfare of persons and property to enact a moratorium for a limited temporary basis to allow time for the Shiawassee County Planning Commission to review certain requirements of Sec. 4.3.76 of the Shiawassee County Zoning Ordinance, particularly those provisions regulating height, setbacks, shadow flicker, noise impacts, and decommissioning costs of Wind Energy Conversion Systems and recommend any revisions necessary for the protection of the public health, safety and welfare; and

WHEREAS, the Board has determined that adopting the Ordinance To Impose A Moratorium On The Issuance Of Permits, Licenses Or Approvals For Wind Energy Conversion Systems, attached hereto as Exhibit A, is in the best interest of the public health, safety and welfare of County residents; and

WHEREAS, the County has made good faith efforts to develop policy with input from the townships within the 12-month moratorium period authorized by Ordinance 17-01-01 adopted by the Shiawassee County Board of Commissioners on January 13, 2017,

but progress has been delayed due to the need to gather additional information from the townships making it necessary to extend the moratorium period through June 30, 2018; and

THEREFORE, be it resolved by the Board of Commissioners of Shiawassee County, Michigan as follows:

1. Ordinance No. 17-01-01, An Ordinance To Impose A Moratorium On The Issuance Of Permits, Licenses Or Approvals For Wind Energy Conversion Systems, attached as Exhibit A, is hereby amended to extend the term of the moratorium through June 30, 2018.
2. The Ordinance, attached as Exhibit A, shall be filed with the County Clerk.
3. In accordance with MCL 46.11, the County shall publish notice of adoption of the amended Ordinance in a newspaper of general circulation in the County.
4. Any and all resolutions that are in conflict with this Resolution are hereby repealed.



and \$37,500.00 for the years 2017, 2018 and 2019 to be paid from 101-202-805.000, and authorize the Board Chair to execute all necessary documents. Motion carried with the following roll call vote of 6 yeas: Commissioners McMaster, Coscarelli, Bruff, Marks, Bartz and Root. Nays: 1. Commissioner Holzhausen.

It was moved by Commissioner Marks, seconded by Commissioner Bartz to authorize the Veterans Affairs Committee to use donated funds from Fund 293 and Capital Outlay Funds from Fund 291 to purchase a 2018 Ford Flex Vehicle in the estimated amount of \$14,700.00 which represents half the cost of the vehicle with the other half of the cost being paid through a DAV grant. The total final cost will not be known until after January 01, 2018 and delivery on the vehicle will not be taken until after mid-2018. It was moved by Commissioner Marks, seconded by Commissioner Bartz to amend the Veterans Affairs Committee to use donated funds from Fund 293 and Capital Outlay Funds from Fund 291 to purchase a 2018 Ford Flex Vehicle in the estimated amount of \$14,700.00 which represents half the cost of the vehicle with the other half of the cost being paid through a DAV grant. 


