PREAMBLE: The Shiawassee County Zoning Ordinance (“Ordinance”) as adopted by the Board of Commissioners of the County of Shiawassee, pursuant to Public Act 183 of 1943 (as amended and replaced by Public Act 110 of 2006, as also amended), may be amended following the procedures outlined in said Ordinance and in compliance with Public Act 110 of 2006, as amended.

WHEREAS: John and Matthew Slocum filed a petition and paid all applicable fees to rezone a parcel of land from A-2, Agricultural Production/Rural Residential to B-3, Highway Service; a portion of said parcel of land being located in Section 4 of Perry Township (Parcel Id.# 014-04-400-001-06) and legally described as follows:

**014-04-400-001-06:** Part of the Northeast ¼ of the Southeast ¼ of Section 4, T5N-R2E, Perry Township, Shiawassee County, Michigan, described as beginning at the East ¼ corner of said Section 4; thence S01°46’28”E on the East line of said Section 4 a distance of 350.00 feet; thence N90°00’00”W 622.3 feet; thence N01°46’28”W 350.00 feet to the East and West ¼ line of said

Section 4; thence S90°00’00”E on said East and West ¼ line a distance of 622.34 feet to the point of beginning, containing 5.00 acres, more or less. Subject to the use of the Northerly 33.00 feet thereof as Winegar Road. Also subject to the use of the Easterly 50.00 feet thereof as State Highway M-52. Also subject to all other easements and restrictions of record.

WHEREAS: The Shiawassee County Planning Commission held a duly advertised and noticed public hearing on August 26, 2020 considering the request; and

WHEREAS: Upon reviewing the request, reviewing conditions offered by the applicant, accepting comment at the public hearing, and deliberating the findings of fact as set forth in Article 19, Section 19.5 of the Ordinance, the Shiawassee County Planning Commission recommended approval of the request to the Shiawassee County Board of Commissioners;

THEREFORE BE IT RESOLVED: The Shiawassee County Board of Commissioners, having considered the recommendation and findings of the Shiawassee County Planning Commission and having reviewed the request of the applicant, ordains to amend the official Zoning Map (Article 2, Section 2.1.2) of the Ordinance by changing the zoning designation of the above referenced property from A-2, Agricultural Production/ Rural Residential to B-3, Highway Service. With the following conditions, as offered by the applicant. The subject property shall not be permitted to be utilized for the following uses, as defined by the Shiawassee County Zoning Ordinance: Billboards, Indoor Entertainment Establishments, Food Service Establishments, and Sexually Oriented Businesses.

Employees who work for Shiawassee County at or before the time of this resolution, having a break in employment, may rejoin the MERS Defined Benefit Plan. Further, new employees who come to work for Shiawassee County from another participating MERS Defined Benefit Plan employer may join the Shiawassee County Defined Benefit Plan.
