The meeting was called to order by Chairman Garber at 5:00p.m. followed by the Pledge of Allegiance.

Call to the Public: Joe Schneider, Durand – Veterans Van

It was moved by Commissioner Holzhausen, supported by Commissioner Marks to move to the next Committee of the Whole meeting consideration to authorizing the Health Department to contract with Dr. Dennis Chernin for Medical Director Services in the amount of \$37,200 from 1/1/2020 to 12/31/2020, and authorize the Board Chair and Health Director to execute the documents. Motion carried.
