NOTICE OF MEETING OF BOARD OF DETERMINATION

NOTICE IS HEREBY GIVEN to you as a person liable for an assessment that the Board of Determination, composed of Gary Bendall, Danny Miller, Dave Mitchell, and Edward Pincik (Alternate), will meet on **Monday, November 9, 2020 at 6:30 p.m. at the Shiawassee Township Hall, 3719 Grand River Road, Bancroft, Michigan 48414** to hear all interested persons and evidence and to determine whether the actions prayed for in a Petition dated September 15, 2020 for the cleaning out, relocating, widening, deepening, straightening, tiling, extending, improving, relocating along a highway, providing structures, mechanical devices and pumping equipment, adding lands, adding branches and adding a relief drain of the drain known and designated as the Case #2 Drain, and is necessary and conducive to the public health, convenience or welfare of Shiawassee Township, County of Shiawassee, State of Michigan, in accordance with Sections 72 and 191 of Act No. 40, PA 1956.

Proceedings conducted at this public hearing will be subject to the provisions of the Michigan Open Meetings Act but will also follow the emergency order issued on October 9, 2020 by the Michigan Department of Health and Human Services, pursuant to MCL 333.2253 – Gathering Prohibition and Mask Order (the “MDHHS Order”). The MDHHS Order provides limitations on indoor gatherings and requires face covering for certain events. Attendance is limited to 20% of the venue’s seating capacity or 20 persons per 1,000 square feet. Seating capacity at this public meeting is limited to 40 attendees. All attendees must wear face coverings and practice social distancing, and conform to all rules and requirements of Shiawassee Township and the Office of the Shiawassee County Drain Commissioner. In lieu of attending in person, the public may also participate through online video conferencing. Members of the public will only be able to speak during the public comment portions of the meeting. To provide for orderly public participation, a person wishing to speak must state their name and request to be recognized by the Board. The Board of Determination will recognize all persons wishing to speak during the public comment portion of the meeting.

Information regarding this meeting may be obtained from the Shiawassee County Drain Commissioner. Persons with disabilities needing accommodations for effective participation in the meeting should contact the Shiawassee County Drain Commissioner at the number noted below (voice) or through the Michigan Relay Center at 711 (TTY) at least 24 hours in advance of the meeting to request mobility, visual, hearing or other assistance. YOU ARE FURTHER NOTIFIED that persons aggrieved by the decisions of the Board of Determination may seek judicial review in the Circuit Court for the County of Shiawassee within ten (10) days of the determination. If the actions prayed for in the Petition are determined to be necessary

and conducive to the public health, convenience or welfare, a special assessment may be levied against properties that benefit from the project. A landowner of or party of interest to property to be assessed, or their agent, may appear in person to comment on the necessity of the project.
